



Dear Parent/Guardian

We are so pleased that your child enjoyed their Free Taster with Invidia Voices and has decided to join us! We welcome children into the choir however as an organisation we cannot take responsibility for any person under the age of 18. Our Children Policy is as follows:

ACCEPTING CHILDREN INTO THE CHOIR:

- *If a child is under the age of 12, they MUST be chaperoned by a parent or guardian. This person does not have to be a member of Invidia Voices unless they wish to participate in the session. If this is a case a membership must be set up for this person.*
- *Children aged between 12 and 16 are allowed to attend rehearsals on their own, however a waiver MUST be signed by a parent/guardian stating that they are happy for their child to attend the rehearsal on their own and that they understand that Invidia Voices will not accept any responsibility for the child during that session or during performances.*
- *Children ages 16-18 can attend rehearsals on their own without a waiver being signed however Invidia Voices cannot accept responsibility for them.*

If your child falls into the first category (i.e. aged under 12) please complete **Form 1 overleaf**. If your child falls into the second category (i.e. aged 12-16) please complete **Form 2 overleaf**. Please return the form to me either via post, email or send it along with your child when they attend the rehearsal.
